


Cases Over Time






National Effective Growth Rate


United States COVID Effective Transmission Rate




National vs Utah Effective Growth Rate



State Active Cases as of May 20, 2020




State Growth as of May 20, 2020





Utah's Experience with COVID-19

Utah Active Cases and Transmission Rate Over Time




Utah Cases and Growth






Changing Hotspots

County Share of Total Active Cases


